OBJECTIVE OF THE CALL

The IMIM Foundation announces one open position for a **Recognised Researcher (R4)** with the objective of incorporating an international leader researcher to one of the main research areas of IMIM: **Cancer, Epidemiology and Public Health, Clinical Translation, Biomedical Informatics, or Neurosciences.**

JOB CONDITIONS AND PROFESSIONAL PROFILE

Incorporation to the IMIM Foundation through a permanent full-time work contract. Competitive remuneration will be based on the merits of the candidate.

The **mission** of the job is to carry out research of excellence and to achieve effective transfer of this to the most important health problems in the population, observing, at all times, the Institute's Code of Good Practice and Code of Ethics.

The main functions of the position include the planning and development of research projects, publication of scientific articles in high impact journals, participation in international projects, the transfer and exploitation of research results, dissemination of research to the scientific community and outreach to society in general, as well as the development of their team.

ELIGIBILITY CRITERIA[#]

The candidate must hold a PhD degree and must have a trajectory of scientific excellence internationally recognized.

DOCUMENTATION TO BE SUBMITTED

To be eligible to participate in the selection process, candidates must present the documentation listed below within the period established:

1. CV according to the model attached in [Annex I](#).
2. DNI/NIE/Passport (National Identity Number).
3. PhD Certificate (simple copy).
4. 5-Year Career Development Plan (maximum recommended extension 5 pages). Attached in [Annex II](#) some recommendations to include on it.
5. Two letters of reference.

DEADLINES AND DOCUMENT PRESENTATION

In order to present the candidature, it will be necessary to fill in the form available on the website of the Hospital del Mar Research Institute, in the section corresponding to this call for applications, and attach all the required documentation, in the form requested in these rules. The deadline for submission of applications is up to and including 24 November 2024. DEVELOPMENT OF THE SELECTION PROCESS AND PROFESSIONAL TESTS[#]

- a) **Provisional results.** A provisional list of applicants admitted and excluded will be published on www.researchmar.net. Excluded applicants will have 10 calendar days to present any possible claims and it will be resolved within a period of 5 calendar days. After this period, the list of final admitted applicant will be published on www.researchmar.net.
- b) **Evaluation of merits.**
 1. A panel of experts ([Annex III](#)), including members from the External Scientific Advisory Board (ESAB) of Hospital del Mar Research Institute, will evaluate the merits and plans presented by the admitted candidates according to the scale expose in [Annex IV](#) in order to select up to 6 of them.
 2. The selected candidates will have to defend their Career Development Plan to the Panel, in English. After, the panel will prioritize the candidates.

In case none of the candidate meet the minimal criteria for a R4 position the call can be declared void.
- c) **Director interview.** The Director of Hospital del Mar Research Institute will interview with the top 3 prioritized candidates to explore their starting package needs. A final offer will be made to the first candidate. If it is declined, an offer will be made to the following candidates according to the ranking according to the [Annex IV](#).
- d) **Definitive results.** The final lists, the recruitment proposal and the aforementioned agreement will be published on www.researchmar.net.
